Ground-breaking Ceremony Kicks Off Emergency Room Expansion and New MRI at SJH Elmer Hospital

South Jersey Healthcare hosted a ground-breaking ceremony for the expansion of the Emergency Room (ER) facilities and the addition of a new Magnetic Resonance Imaging (MRI) machine to the Radiology Department of SJH Elmer Hospital. The ceremony marks the official start to renovations that will nearly double the size of the ER from 4,975 square feet to over 10,000 square feet with the total cost projected at \$6.9 million.

In conjunction with the ground-breaking, the SJH Foundation also launched the *Building on Excellence* Capital Campaign to raise \$1.5 million towards this project. The remainder of the needed dollars will be funded by operations from the health system. To date, the SJH Foundation has raised
